# LCA EXPOSES Rodent Ranch

LCA investigators were shocked when they uncovered numerous horrors at one Southern California breeding facility this past June.

An anonymous tip led LCA investigators to Rodent Ranch, a Southern California facility that breeds and sells reptiles along with guinea pigs, rabbits, mice and rats for sale to pet stores. While some of the animals are purchased as pets, most were being bred as “feeder” animals for reptiles. Here’s what LCA investigators discovered:

- Dead animals throughout the premises – some even outside of the facility.
- Filthy cages filled with feces and decomposing carcasses.
- Mice and rats that had been cruelly killed by putting them in a freezer.
- Animals in conditions so cramped they were climbing over each other.

Rodent Ranch owner Rick Perry started a massive clean-up when Los Angeles investigative reporter David Goldstein showed up with a camera crew. Goldstein went on to air LCA’s undercover footage on the evening news.

LCA President Chris DeRose spoke candidly about the investigation. “The conditions are deplorable,” DeRose told Goldstein. “(Perry) should have been fined, summoned...he should have been shut down.” After Goldstein’s piece aired, LCA received hundreds of calls from horrified viewers.

Goldstein’s segment and LCA’s undercover footage were able to accomplish more than the Los Angeles Police Department and the Los Angeles County Department of Animal Regulation combined, both of whom had been provided with evidence collected by LCA.

Sadly, neither was able to do anything since Rodent Ranch was not committing any violation of the city’s ordinances. Even worse, there were no violations of Animal Welfare Act (AWA) which provides no protection for small companion animals such as mice and rats. “From our point of view, everything is up to code,” Department of Animal Regulation Spokesperson Jackie David told the media.

LCA disagrees and will work until all animals – including those at Rodent Ranch, receive protection.

## GIVE ANIMALS A FIGHTING CHANCE!

## The AWA and Small Animals

*One LCA member called to ask us if small companion animals are protected under the Animal Welfare Act (AWA).*

*Recently, the U.S. Department of Agriculture (USDA) agreed to modify its definition of the word “animal” so that rats, mice, and birds would be included. While this would finally provide these animals with some protection, it’s no surprise that the biomedical industry is currently attempting to block the USDA’s proposal.*

*After suffering for years without any protection, this important change to the AWA would positively impact more than 20 million rats, mice, and birds, who comprise 95 percent of all animals used in laboratory research each year if we are able to defeat the biomedical research community’s efforts.*

# LCA Gives *Sex and the City* Some Fashion Advice

LCA informed *Sex and the City* that there's nothing sexy about fur! The popular television show committed a fashion faux pas last season by regularly featuring fur clothing. "We are very dismayed that *Sex and the City* has become a promotional tool for animal suffering..." LCA President Chris DeRose said in a letter sent to the show's producers this summer.

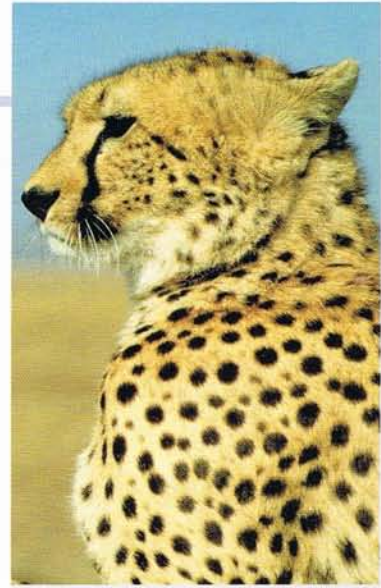
Recognizing that television and film can create fashion trends in a flash, DeRose asked *Sex and the City's* producers to immediately halt the use of fur on the program. DeRose's concerns were well founded—even the fashion industry paper *Women's Wear Daily* stated that *Sex and the City* might provide a boost to lagging fur sales.

LCA gave producers the benefit of the doubt by assuming they were unaware of the cruelty perpetuated by the fur industry. "Perhaps you did not know that (fur bearing) animals are kept in tiny cages where they are not able to act out any of their basic instincts. This leads to neurotic behavior and self-mutilation..." DeRose said.

Soon after DeRose's letter, *Sex and the City* removed all displays of fur from their website and publicly stated that it would only use fake or vintage fur. While it's a partial victory for the animals, we hope that *Sex and the City* viewers will let the show know that no fur is the kindest fashion statement of all!

**WRITE** to *Sex and the City*. Thank costume designer Pat Field for her cooperation, but politely request that *Sex and the City* completely eliminate all fur from this popular television show.

# LCA Hopes to Brighten the Future

# for *Racing Greyhounds*



LCA sent out a postcard to our Massachusetts members asking them to vote "yes" for a statewide ban on greyhound racing.

LCA teamed up with Massachusetts' Greyhound Racing Ends Year 2000 (GREY2K) when they asked for our help to get greyhound racing banned in their state. Thanks to a campaign spearheaded by GREY2K, an initiative was placed on the November ballot asking voters for their support.

LCA investigators met with a former greyhound trainer to document the horrors of greyhound racing. "I was shocked and horrified at the conditions these dogs are kept in," LCA Cruelty Investigator Mark Powers said adding, "The greyhound racing industry is duping the public into believing that these dogs are being cared for when in reality, hundreds of dogs are being murdered each week."

Track life is equally tragic. Many of these majestic dogs spend over 20 hours each day locked in tiny metal crates, are fed raw, rancid meat and denied basic veterinary care. One former trainer told LCA investigators of how dogs were often forced to ingest poisons like bleach before a race so that the predetermined "winner" would easily win the race drug-free.

As a reminder, LCA sent postcards to our 1,700 Massachusetts members reminding them to vote to ban greyhound racing in the state. We're hoping that Massachusetts will soon be free of this cruel "sport," and that the 15 other states where greyhound racing is still legal will follow suit.

LCA's investigation revealed:

- Allegations that dogs were often drugged or poisoned to throw race results.
- Filthy, garbage-ridden kennels and dog runs.
- Dogs injured from racing.
- Dozens of "slow" greyhounds who were euthanized on a weekly basis.

The racing industry wants the public to believe that racers have happy lives upon retirement from the track. The facts, however, are grimmer than the rosey picture they paint. Approximately 20,000 greyhounds are killed every year across America when they are no longer considered competitive. Many are shot, electrocuted or starved to death. While most greyhounds live 12-15 years, the average lifespan of a racing greyhound is 3-4 years.

One of the most horrible fates awaiting many greyhounds is their sale to medical researchers. Each year thousands of these beautiful and trusting dogs are maimed and killed in horrible, useless experiments.

## YOU CAN HELP GREYHOUNDS, TOO!

**DON'T** support greyhound racing if you live in one of the 16 states where racing is legal. Ask friends and family members to do the same.

**DO** encourage adoptions of retired greyhounds, but only from organizations that do not support the greyhound racing industry.

# LCA Targets Burlington Coat Factory on Their Own Turf!

## Anti-Fur Ad Appears in Burlington Newspaper

LCA targeted Burlington Coat Factory (BCF) in its own backyard. We placed a brutally honest ad about fur in a community newspaper in Burlington, New Jersey where BCF is headquartered.

Appearing in the *Burlington Mail*, the ad shows a pitiful coyote in the grip of a painful steel-jawed leghold trap. "This ad sends a strong message to the people of Burlington that there's nothing glamorous about fur," says LCA President Chris DeRose.

More than 12 million trapped animals suffer each year. Seventy-five percent of all animals are non-target species, including dogs, cats, deer and many endangered species.

While LCA worked to educate individuals on the East Coast, our West Coast supporters peacefully demonstrated at a major BCF in Los Angeles. Over 20 LCA members gathered at the store to speak with consumers about the cruelty of fur and fur-trim products. "We're out there because we need to educate Burlington consumers about the plight of fur-bearing animals. Most people never stop to consider the suffering these animals endure," says LCA staff member Sue Marschner, who led the demonstration. "All of our efforts combined will make a difference."

# LCA to Korea

## Stop Selling Dog Meat!

Hoping to draw attention to the suffering of Korean dogs, LCA recently protested the sale and preparation of dog meat in restaurants throughout Korea.

Korean folklore has perpetuated the cruel myth that dog meat containing the hormone adrenaline has magical, aphrodisiacal qualities. To produce adrenaline-filled meat, thousands of Korean dogs are slowly tortured before being killed every year.

While the South Korean government responded to this cruelty by outlawing the "cooking and selling of dog meat," as well as "the infliction of unnecessary pain (upon dogs)," the laws on the books are not strictly enforced.

In order to put pressure on the South Korean government, LCA supporters stood outside of the Korean embassy in Los Angeles informing the press and the public of the horrific torture these dogs endure. LCA

supporters across the United States are also contacting sponsors of the upcoming World Cup Soccer 2002 match being held in Seoul, South Korea asking them to withhold their sponsorship until Korean animal protection laws are strictly enforced.

"(Getting sponsors to boycott the World Cup) may be our only opportunity to spare one million dogs the fate of death by torture," says the International Aid for Korean Animals (IAKA), the organization which brought this atrocity to LCA's attention.

A South Korean bill introduced by the opposition to legalize dog eating was defeated in Parliament. "They are good people who do not deserve to be associated with such monstrous cruelty," says IAKA, recognizing that the vast majority of Koreans oppose this cruel practice. LCA hopes that the Korean government will follow the wishes of its people by taking a stronger stand against animal cruelty.

# Dog Fighting:

## What You Need to Know

**D**og fighting is a sadistic “sport” in which two dogs are placed into a ring or pit and then fought until one of the dogs is either severely injured or killed. Cheering spectators typically place bets on the dogs with thousands of dollars wagered on a single fight. Thankfully, dog fighting is now a felony in most states.

While studies have shown that no particular breed is any more aggressive than another, pit bulls and other large dogs such as rottweilers, Doberman pinschers and German shepherds are typically selected. Dogs involved in a fight will be forced to fight until one passes out or dies. It can take up to two hours for this brutal act to end.

A dog’s “training” often includes taunting, beating, and starvation. Dogs forced to fight are often encouraged to kill small animals such as cats and rabbits to increase their aggressive behaviors.

Conducted in abandoned homes, warehouses or basements, dog fighting is typically symptomatic of other illegal activities. Cruelty investigators often report that dog fighting typically attracts individuals involved in gambling, drug sales, illegal weapons, gangs and prostitution. It’s not surprise that people involved in dog fighting typically have a history of violence or criminal behavior. One dog fight raid conducted in Arkansas

several years ago resulted in one of the largest caches of illegal drugs, gambling, money, and handguns ever seized in that state.

Sadly, adults involved in dog fighting often bring their children to watch. Researchers have discovered that children who have been exposed to dog fighting grow up believing that this is an acceptable form of entertainment. These children are often desensitized to violence and often exhibit violent behavior toward both animals and people themselves.



### If You Suspect Dog Fighting...

**Do not endanger yourself - most individuals involved in dog fighting have a history of violence. Report any suspicious activity to your local animal care and control agency or police department and ask that your personal information be kept confidential. Remember, reporting dog fighting will reduce illegal activities in your area.**

### LCA Investigators Rescue Pit Bull Puppies

Acting on a tip from neighbors, LCA investigators were able to rescue a litter of pit bull puppies from a Los Angeles neighborhood notorious for illegal dog fighting activity. "By saving this one litter, we've saved dogs that would have otherwise had a miserable life," LCA investigator Muriel Vernon said.

As investigators approached the property they saw the pups' mother chained to a doghouse in a yard filled with graffiti covered walls and strewn with debris.

The dogs were relinquished to LCA after our investigations team informed the dogs' owner of the city's stringent anti-dog fighting and spay/neuter laws. The dogs' owner also promised LCA investigators that the pups' mother, who'd already given birth to several litters, would be sterilized, vaccinated and licensed. The pups were later transported to a Los Angeles humane organization for medical attention, sterilization and adoption.



# Don't Let Wal-Mart and Trader Joe's *DUCK* This Issue!

## Popular Stores Now Selling Factory Farmed Duck Meat

Factory farming doesn't just mean suffering for farm animals. Sadly, ducks now join the long list of creatures being exploited and killed for food. That's why LCA is asking you to contact two popular stores - Wal-Mart and Trader Joe's, to demand that they stop selling duck meat.

"I was shocked to find that most farmed ducks never even see water, except to drink," says Lauren Ornelas, campaign director for the animal advocacy group Viva. Ornelas described the squalid conditions where thousands of ducks are forced to live. "One little duckling sat forlornly staring out into the street from behind a mesh fence, wet manure on his face and body. In the right conditions, he - like all ducks - would keep himself pristinely clean. But in these places, the filth builds up and they have no way to remove it."

Slaughter methods are no more humane. Approximately 1 million birds are conscious when their throats are cut, while United States Department of Agriculture (USDA) statistics indicate that thousands are still alive while they are submerged into scalding water to be de-feathered.

Every call and letter that we send to Wal-Mart and Trader Joe's will make a difference for these unlucky ducks.

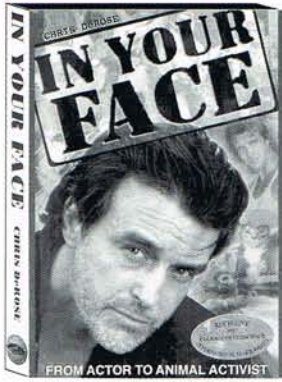

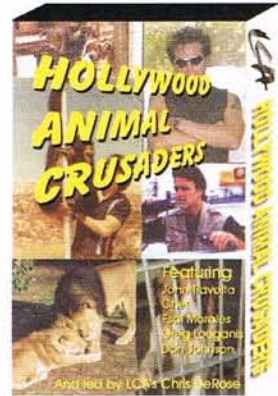

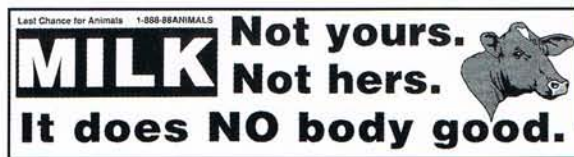
